
**OFFICE MEMORANDUM**

**Subject: Appointment of Shri Anand Vijay Jha, IRPF(98) as Chief Vigilance Officer (CVO) in Cotton Corporation of India (CCI), Mumbai.**

Reference: Ministry of Textiles' O.M. No. 31012/8/2013-Vig dated on 5<sup>th</sup> September, 2013 on the subject mentioned above.

2. The Competent Authority has approved the proposal of the Ministry of Textiles for appointment of **Shri Anand Vijay Jha, IRPF(98)** as Chief Vigilance Officer (CVO) in Cotton Corporation of India (CCI), Mumbai under the Ministry of Textiles. The officer will have the option to draw either the pay of the post or the pay in the parent cadre plus deputation allowance thereon plus personal pay, if any.
3. On his appointment as CVO in Cotton Corporation of India (CCI), Mumbai, Shri Anand Vijay Jha, IRPF(98) will be entitled for an initial deputation tenure of three years in CCI, Mumbai which is extendable for a further period of two years in the same CPSE (total 5 years) with the prior clearance of CVC and DoP&T.
4. The appointment of Shri Anand Vijay Jha, IRPF(98) to the aforesaid post shall be effective from the date he assumes the charge of the post, or until further orders, whichever is earlier.
