OFFICE MEMORANDUM

Subject: Appointment of Smt. Uma Nanduri, IFS(OR:93) to the post of Chief Vigilance Officer (CVO) in the National Projects Construction Corporation Limited (NPCC), New Delhi.

Reference: Ministry of Water Resources' O.M. No. 9/1/2010-PSU/1361 dated 19.12.2012 on the subject mentioned above.

2. The Competent Authority has approved the proposal of the Ministry of Water Resources for appointment of Smt. Uma Nanduri, IFS(OR:93) to the post of Chief Vigilance Officer in National Projects Construction Corporation Limited (NPCC), New Delhi. The officer will have the option to draw either the pay of the post or pay in the parent cadre plus deputation (duty) allowance thereon plus personal pay, if any.

3. On her appointment as CVO, NPCC, New Delhi, Smt. Uma Nanduri, IFS(OR:93) would get a tenure of three years or upto 31.3.2016 whichever is earlier. In case her three years tenure ends before 31.3.2016, it would be extendable upto that date with the prior approval of the Central Vigilance Commission and Department of Personnel & Training.

4. The appointment of Smt. Uma Nanduri, IFS(OR:93) to the aforesaid post shall be effective from the date she assumes the charge of the post.
