NOTIFICATION

G.S.R. In exercise of the powers conferred by Section 7 of the Central Vigilance Commission Act, 2003 (45 of 2003) read with rule 4(1)(b) of the Central Vigilance Commission (Staff) Rules, 2007 and in supersession of Central Vigilance Commission (Stenographers) Recruitment Rules 1975, Central Vigilance Commission Group C posts (Recruitment of Staff) Rules, 1977, in so far as it relates to the posts of Upper Division Clerk, Lower Division Clerk, Staff Car Driver and Dispatch Rider, Central Vigilance Commission (Group 'D' posts) Recruitment Rules, 1988 and Central Vigilance Commission (Data Entry Operator) Recruitment Rules 1993, except in respect of things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to Group 'C' posts in the Central Vigilance Commission, namely:-

1. Short title and commencement – (1) These rules may be called the Central Vigilance Commission (Group 'C' posts) Recruitment Rules, 2016.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of post, classification and Pay Band and Grade Pay or scale of pay.--The number of posts, their classification and the Pay Band and Grade Pay or scale of pay attached there to shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment, age limit, and other qualifications, etc. – The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 13 of the said Schedule annexed to these rules.

4. Disqualifications- No person –

- a) who has entered into or contracted a marriage with a person having a spouse living, or
- b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to any of the said posts:

provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax the rules- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, and in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.

7. Saving- Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes. the Schedule Tribes Other Backward Classes. Ex-Service personnel and other special categories of person in accordance with the orders issued by the Central Government from time to time in this regard.
