

**Minutes of the meetings of the National Committee held on 22.10.2019 and 23.10.2019**

**Sub: International Youth Contest of Social Anti-Corruption Advertising “Together Against corruption!” - assessment of works of contestants and shortlisting of winners in each category (poster/video) by the National Committee**

The meeting of the National Committee under the Chairmanship of Shri Anindo Majumdar, Secretary, CVC was held on 22.10.2019 and 23.10.2019 at Satarkta Bhawan, INA, New Delhi.

Shri Suresh K Reddy and Shri G. Sajan could not attend the meeting. However, the Directorate General, Doordarshan nominated Shri Anoop Khajuria, Sr. Producer, Doordarshan to assist the National Committee who attended the meeting on 23.10.2019.

2. At the outset the Chairman welcomed the members. Smt. Archana Varma, Additional Secretary informed the details of the online contest. It was also informed that the DoPT vide OM No. 371/29/2014-IC Vol-II dated 15.10.2019 had constituted the National Committee under the Chairmanship of Secretary, CVC. The mandate of the Committee was to shortlist 1<sup>st</sup>, 2<sup>nd</sup>& 3<sup>rd</sup> winning entries in each category (poster/video) as well as 10 best posters and 10 best videos for posting on the official website [www.anticorruption.life/en](http://www.anticorruption.life/en) by 25.10.2019 (semi-final) in accordance with the prescribed criteria (Contest Rules). The 1<sup>st</sup> winning entry shall be submitted to the Organizer i.e. Prosecutor General Office of Russian Federation for onward transmission to International Jury for Finals. The Committee shall submit all the semi-final short-listed works to the Organizer latest by 31.10.2019.

3. The Committee was further informed that an Agenda for the meeting detailing the terms of reference alongwith soft copies of all the posters and videos was circulated on 18.10.2019 among the Members for their advance perusal.

4. The Committee noted that 3459 posters and 449 videos had been received from the contestants. The Committee deliberated upon each entry of the contestants in the light of the criteria prescribed by the Contest Rules. All the posters and videos of the contestants were screened before the Committee during the meetings held on two days.

6. After detailed deliberation the National Committee shortlisted 11 works of the contestants in each category. The list of shortlisted works of contestants in each category (Poster/Video) is enclosed as Annexure-I and II. The entries at S.No. 1, 2 & 3 of each list were declared as Winners for Semi-Final stage in seriatim for the purpose of award of prizes by DoPT. Further, the entry at S. No. 1 of each list at Annexure-I & II was declared as Winner for the purpose of onward transmission to the Organizer i.e. Russian Federation.

The meeting concluded with a vote of thanks to the Chair.
