2.1 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose name has been mentioned at Sl. No. 1 and 2 of the Select List 2018 shall be placed below Shri Ajay Chagti, Junior most promotee IAS officer of 2010 batch (SL-2017 –UT segment) of Joint AGMUT Cadre and above Shri Sang Phuntsok, the senior most promotee IAS officer of 2010 batch (Non-SCS Category of Arunachal Pradesh Segment) of Joint AGMUT Cadre.

2.2 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose name has been mentioned at Sl. No. 3 to 19 of the Select List 2018 shall be placed below Smt.
