Panda, Junior most promotee IAS officer of 2008 batch (SL-2016) and above Shri Krishna Mohan Uppu, the senior most RR IAS officer of 2009 batch of joint AGMUT cadre.

2.2 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose name has been mentioned at Sl. No. 2 to 7 of the Select List 2017 (SCS Category) be placed below Ms Rinchin Tashi, Junior most promotee IAS officer of 2009 batch and above Dr. Lalrozama, junior promotee IAS officer of 2009 batch (Non-SCS) of joint AGMUT cadre.

2.3 As per Rule 4 of the IAS (Regulation of Seniority) Rules, 1987, the officers whose name has been mentioned at Sl. No. 8 to 14 of the Select List 2017 (SCS Category) be placed below Shri Arti Lal, Junior most RR IAS officer of 2010 batch and above Shri Sang Phuntsok, a junior IAS officer of 2010 batch (Non-SCS Category) of joint AGMUT Cadre.

3. Inter-se-seniority /year of allotment of the above officer with respect to officers of other segments would be determined later on as and when the inter-se-seniority of segments of AGMUT Cadre is decided by the Cadre Controlling Authority.
