Subject: Training Programme on Defence/Internal Security at the National Defence College, New Delhi- Beginning January 2014 for a duration of 11 months – clarification regarding the admissibility of Travelling Allowance for the IAS officers of the Central Government, State Government and Union Territories coming from outside Delhi.

Madam/Sir,

I am directed to refer to this Department's Circular of even No. dated 24th June, 2013 addressed to the Chief Secretaries of all the State Governments/ Administrators of UTs and the Secretaries of all the Ministries/Departments and to state that with regard to the admissibility of Travelling Allowance for the IAS officers of the Central Government, State Government and Union Territories coming from outside Delhi to participate in said programme, the existing terms and conditions of the NDC course as mentioned in the circulars/orders of Ministry of Defence and DOPT, Training Division are silent. This has led to unnecessary confusion and scope for subjectivity. To remove this confusion and to make the terms and conditions more explanatory/speaking and facilitatory, it has been decided to include the under mentioned in the APPPA programme at IIPA, New Delhi sponsored by Training Division, DoP&T:

" IAS Officers posted in the Central Government, State Government and Union Territories coming from outside Delhi to participate in the programme will be allowed one of the following two options by the sponsoring authorities:-

(a) The officers will be treated as on duty on tour. They will draw travelling allowance as on tour and allowances as per para 11(a) of the Ministry of Finance, Department of Expenditure O.M. 19030/2/86-E-IV dated 24.3.86 amended from time to time.

OR

(b) The officers will be treated as on transfer. They will not be entitled to the Government accommodation at the original place of posting. They will draw

the pay and allowances as admissible to them when they are posted to Delhi."

2. All the Central Ministries/Departments in the Government of India and the State Govts/UT Administrations are requested to bring this fact to the notice of all the concerned officers who apply for the above mentioned course.
