CIRCULAR

Subject Long/short-term training programmes under DFFT Scheme for FY 2011-12 – 2nd Deficiency List.

With reference to the subject mentioned above and in continuation of Training Division's Circular of even number dated 8th October 2010, this is to inform that applications of number of officers received through proper channel for long/short-term programmes to be conducted under the DFFT scheme during 2011-12, have certain deficiencies in Annexure II filled by their respective controlling authorities.

2. 4. It is further pointed out that application of a large number of officers who have already applied online, have not been forwarded by their respective CCAs. CCAs are requested to forward such applications to this Department latest by 24th January 2011 positively.
