Constitutional Validity of the Guidelines was
The W.Ps filed by the Doctors questioning the applicability of Article 371(D) of the constitution contending that the post of Associate Professor which is a State wide post to which the Presidential Order does not apply, were discussed in detail and it was *decided to refer to the G.O. of the Government to take the necessary steps* decided that the Solicitor General/ Attorney General will be requested to defend the cases. *The Government of AP and TS may kindly request the A.G. to attend on his behalf in all such cases.*





Sri R. Prem Kumar, Senior Assistant, SR 83 of Director of Health




