Sub: Computation of reservation – implementation of the judgment of Hon'ble Supreme court in the matter of Union of India & Anr. Vs. National Federation of Blind & Ors.

The undersigned is directed to refer to this Department's O.M. of even no. dated 20.03.2014 regarding judgment of the Hon'ble Supreme Court pronounced on 08.10.2013 in the matter of Civil Appeal No. 9096 of 2013 (arising out of SLP(civil) No. 7541 of 2009 titled Union of India & Anr. Vs. National Federation of Blind & Ors. and this Department's O.M. of even no. dated 03.12.2013.
