- A copy of the updated rules for All India Civil Services Tournaments indicating eligibility criteria, composition of Team Rules of games etc has already been circulated to all concerned.
- The entries may be sent in the prescribed Proforma (Copy attached) directly to the Secretary CCSCSB on the address mentioned above or through email [doptsports@gmail.com](mailto:doptsports@gmail.com) on or before **16<sup>th</sup> March, 2020**. It is requested to ensure that the entries are submitted within prescribed time limit
- List of players along with photocopy of their Identity Card should be authenticated by the authorized officer under his signature & seal.
- All the participants shall carry individual Identity Card/Identity Slip for verification of eligibility criteria by the Organizing Committee/Representatives of the Board at the venue of the All India Civil Services Tournament.
- Addresses, Telephone Numbers, E-mail Addresses may be indicated by the participating State/UTs/RSB's.
- Managers meeting will be held on the evening of a day before the date of commencement of the tournament.
- Every participating team may bring two flags representing their States/UT/Regional Sports Board with them.
- It should be ensured that the team reports half an hour before start of the match at the venue and participates in the tournament as scheduled. Failure to do so shall be treated as an act of indiscipline. All the participants shall maintain strict discipline on and off the venue of the tournament. Any act of indiscipline/misbehavior/misconduct will attract the provision of CCS (Conduct) Rules since Government Employees are treated '**ON DUTY**' during All India Civil Services Tournament.
- Any information regarding change in dates/venue/cancellation etc. about the AICS competitions will be available at <https://dopt.gov.in/about-us/wings-or-division-in-dopt/welfare-divisions>. All the participating teams are, therefore, requested to check the DoPT website from time to time for any possible change before starting their journey.

11. The following categories of employees are **NOT** eligible for participation in AICS Tournaments.
- Uniformed personnel in Defence Services/Para Military Organizations/Central Police organization/Police/RPF/CISF/BSF/ITBP/NSG etc.
  - Employees of Autonomous bodies/undertaking/Public Sector Banks even though administratively controlled by the Central Ministries/State Governments.
  - Casual/Daily wages workers.
  - Employees attached to offices on temporary duty.
  - A newly recruited employee who has put in less than 6 months regular service.
12. The decisions of Umpires shall be final and binding on the competing teams and no representation will be entertained from any quarter in this regard.
13. It is further clarified that matches for 3<sup>rd</sup> place must be organized in order to determine 3<sup>rd</sup> place.
14. Participants are requested to make their own arrangement of accommodation and transport.
