CHAPTER 7

ESSENTIAL STEPS TO BE TAKEN FOR FILLING RESERVED VACANCIES

Para 5(6) of MHA O.M. No. 42/21/ 49-NGS dated 28-1-52 No. 27/2/ 69-Est., (SCT) dated 5-7-69, No. 14/12/67-Est. (D) dt. 10-4-68 and No. 27/6/70-Est. (SCT) dated 5-6-70 MHA O.M. No.27-2-69-Est. (SCT) dated 5-7-69 Deptt. of Personnel O.M. No. 14/17/71-Est. (D) dated 27-11-71.

7.1 The following steps should be taken to bring the reserved vacancies filled by direct recruitment (other than in posts filled through UPSC or through advertisement as the primary source of recruitment, the procedure in respect of which is given in Chapter 8) to the notice of members of reserved:

- (i) Employment Exchange:
 - (a) All vacancies should be notified to the local or the regional employment exchange in the form of requisition given in Appendix 10.
 - (b) A notice of at least 15 days should be given to the Employment Exchanges for sponsoring candidates.
 - (c) The number of vacancies reserved for Scheduled Castes and Scheduled Tribes out of the total vacancies notified should be clearly indicated in item 6(a) of the requisition to the Employment Exchange. The following certificate should also be given below item 9 of the requisition:—

Deptt. of Personnel & A. R. O.M. No. 36014/3/77-Est. (SCT) dated 23-4-77.

- "Certified that the number of vacancies reserved for Scheduled Castes/ Scheduled Tribes and ex-servicemen as mentioned in Col. 6(a) above is in accordance with the reservation quota fixed by Government for these categories".
- (d) When a local Employment Exchange is unable to nominate any suitable candidate, it will refer the vacancy or vacancies to the Central Employment Exchange, Directorate General of Employment and Training, Shram Shakti Bhavan, Rafi Marg, New Delhi-1. Vacancies of scientific and technical nature carrying a pay scale with a minimum of Rs. 425 or more in the pre-revised scale are notified to the Central Employment Exchange and circulated to all Employment Exchanges. Consolidated advertisements are also issued by the D.G., E.&T on all-India basis including in the 'Employment News'.
- (ii) Advertisement in newspapers:
 - (a) If sufficient number of Scheduled Castes/Tribes candidates are not available, through the Employment Exchange to fill the vacancies reserved for them, the vacancies if not already advertised by the Directorate General of Employment & Training should be advertised by the appointing authorities through the Directorate of Advertising & Visual Publicity. Vacancies in posts and services recruitment to which is made on all-India basis [vide Para 2.1(i)] should be advertised in the newspapers approved by the Directorate of Advertising and Visual Publicity for this purpose.
 - (b) Vacancies in Group C or Group D (Class III or Class IV) posts recruitment to which normally attracts candidates from a locality or region, should be advertised in such

- newspapers as may be considered suitable for the purpose through the Directorate of Advertising and Visual Publicity.
- (c) Copies of advertisement should also be endorsed to the Regional or local Employment Exchange.
- (iii) Associations and Organisations of Scheduled Castes and Scheduled Tribes:

Simultaneously with the advertisement the vacancies should be brought to the notice of the Scheduled Castes/Scheduled Tribes organisations as the case may be, listed in Appendix 11. When doing so, it should be made clear to such organisations that their function is limited to advising the Scheduled Castes/Scheduled Tribes candidates about the recruitment proposed and that it will not be for them to recommend or press the names of any individuals. The candidates should apply to the appointing authority either direct or through the Employment Exchanges as the case may be.

Deptt. of Person- (iv) Announcement of reserved vacancies on Stations of All India Radio:

At the time when the vacancies are notified to the local Employment Exchange to suggest names for reserved vacancies and simultaneously with the advertisement, the reserved vacancies should also be notified by the concerned appointing authority/DGE & T to one or more Stations of the All India Radio listed in Appendix 16 for announcement through that Station(s). The announcement of reserved vacancies on Stations of All India Radio should contain an advice to prospective candidates to get their names registered with the Employment Exchange of the area and to approach the Employment Exchange for further assistance.

(v) Intimation of reserved vacancies to Directors of Scheduled Castes/Scheduled Tribes Welfare or Social Welfare in States/Union Territories:

After the Employment Exchange has expressed his inability to sponsor Scheduled Caste/Tribe candidates against vacancies referred to it, the appointing authority should also intimate the reserved vacancies to the Director of Scheduled Castes/Scheduled Tribes Welfare or Director of Social Welfare in the State/Union Territory concerned.

MHA O.M. No. 7.2 The results of submission made by the Employment Exchange of 14/12/67-Estt. (D) Scheduled Caste/Tribe candidates should be intimated to the Employment Exchange within a period of one month. If any of the vacancies reserved for Scheduled Castes/Scheduled Tribes/Ex-Servicemen is not filled by a candidate of the respective category sponsored by the Employment Exchange, specific reasons therefor should be communicated to the Exchange.

MHA O.M. No. 1/ Exchange of vacancies between Scheduled Castes and Scheduled Tribes.

7.3 If a reserved vacancy or vacancies for which recruitment is to be made in accordance with the procedure in para 8.1 above include any vacancy/ vacancies which have been carried forward to the third year of carry forward (excluding the year of original reservation and the year or years in which no vacancy arises) applications should be invited both from Scheduled Castes and Scheduled Tribes candidates but it should be clarified in the requisition/advertisement etc., that for a vacancy or vacancies reserved for Scheduled Castes, Tribes candidates would be considered only in the event of non-availability

of suitable Scheduled Caste cadidates and similarly in respect of a vacancy or vacancies reserved for Scheduled Tribes, Scheduled Caste candidates would be considered only in the event of non-availability of suitable Scheduled Tribes candidates.

7.4 In direct recruitment to be made in accordance with the procedure in para 7.1 above, the interveiw of Scheduled Castes/Scheduled Tribes candidates should be held on a day or sitting of the Selection Committee other than the day or sitting on which general candidates are to be interviewed so that the Scheduled Castes and Scheduled Tribes candidates ate not judged in comparison with general candidates and the interviewing authority/Board is/are prominently aware of the need for judging the Scheduled Castes/Scheduled Tribes candidates by relaxed standards.

Subject: - Vacancies reserved for Scheduled Castes, Scheduled Tribes and Ex-Servicemen.

As Ministry of Finance etc. are aware, certain percentages of vacancies filled by direct recruitment have been reserved for Scheduled Castes and Scheduled Tribes, vide Ministry of Home Affairs Resolution No. 42/21/49-NGS dated the 13th September, 1950. Some percentages of vacancies in Class III and IV posts filled by direct recruitment have also been reserved for Ex-Servicemen, vide Ministry of Home Affairs O.M. No. 14/26/64-Estt.(D) dated 4-7-1966. It has been brought to the notice of this Ministry that while notifying vacancies to Employment Exchange concerned, the fact that a particular vacancy is reserved for Scheduled Castes/Scheduled Tribes/Ex-Servicemen is sometimes not indicated in the requisition placed on the Employment Exchange, with the result that candidates who are eligible for the reserved vacancy are not sponsored by the Exchange. It is requested that while notifying vacancies to the Employment Exchange, it should be clearly indicated in the requisition whether or not the vacancies are reserved for Scheduled Castes/Scheduled Tribes/Ex-Servicemen. Even if a vacancy is unreserved, this should be specifically stated in the requisition. The above points may be brought to the notice of all the authorities concerned, who may also be instructed to intimate the results of submission made by the Employment Exchange within a period of one month. If any of the vacancies reserved for Scheduled Castes/Scheduled Tribes/Ex-Servicemen is not filled by a candidate of the respective category sponsored by the Employment Exchange, specific reasons therefor should be communicated to the Exchange.

Subject:—Employment of Scheduled Castes & Scheduled Tribes—Adequate notice of vacancies to the Employment Exchanges.

It has been brought to the notice of this Ministry that in the absence of adequate notice of reserved vacancies by the employing offices to the Employment Exchanges the latter find it difficult to nominate candidates of Scheduled Castes and Scheduled Tribes against the notified vacancies. It is therefore necessary that the appointing authorities should give sufficient notice to the Employment Exchanges for nomination of suitable candidates against the reserved vacancies. In order to ensure maximum response to the requisition addressed to the Employment Exchanges for this purpose the Ministries/Departments are requested to bring it to the notice of all appointing authorities that a notice of at least 15 days should be given by them to the Employment Exchanges for sponsoring candidates against the reserved vacancies.

Ministry of Home Affairs O.M. No. 27/6/70-Estt. (SCT) dated 5th June, 1970 to all Ministries

Subject:—Notifying vacancies reserved for Scheduled Castes and Scheduled Tribes to Employment Exchanges—Recommendation No. 3 (para 2.13) in the Fifth Report of the Parliamentary Committee on Welfare of Scheduled Castes and Scheduled Tribes.

The undersigned is directed to say that the Parliamentary Committee on welfare of Scheduled Castes and Scheduled Tribes has made the following recommendation in its fifth report:—

Recommendation No. 3 (para 2.13)

"The Committee are unhappy to observe that only about 41 percent of vacancies out of total vacancies notified as reserved for Scheduled Castes and Scheduled Tribes during 1968 were actually filled. They are also unhappy that only 2.3 per cent vacancies were notified as reserved for Scheduled Castes and Scheduled Tribes during 1968. In view of the insignificant percentage of vacancies notified as reserved for Scheduled Castes and Scheduled Tribes, the Committee would like that the Ministries/Departments and other authorities should ensure that percentage of posts intended to be reserved for Scheduled Castes and Scheduled Tribes is duly taken into consideration while notifying the vacancies to Employment Exchanges".

In this connection, a reference is invited to this Ministry's O.M. No. 14/12/67-Est.(D) dated 10th April, 1968 (copy enclosed) in which the Ministries etc. were requested that while notifying vacancies to the Employment Exchanges, it should be clearly indicated in the requisition whether or not the vacancies are reserved for Scheduled Castes/Scheduled Tribes/Ex-Servicemen and that even if a vacancy is unreserved, this should be specifically stated in the requisition. The recommendation of the Parliamentary Committee mentioned above is brought to the notice of the Ministry of Finance etc. They are requested to ensure that the instructions issued in this Ministry's O.M. No. 14/12/67-Est.(D) dated 10-4-1968 are observed by them and their attached and subordinate offices strictly.

Department of personnel O.M. No. 14/17/71-Estt.(D) dated 27th November, 1971 to all Ministries etc.

Subject: - Fourth Report of the Parliamentary Committee on Welfare of Scheduled Castes and Scheduled Tribes-Recommendation No. 32—Certificate regarding number of reserved vacancies included in the requisition.

The undersigned is directed to refer to the Ministry of Home Affairs Office Memorandum No. 2/11/55-RPS, dated the 7th May, 1955 (as amended by the Office Memorandum of even number dated 1st July, 1955 and 6th July, 1956), regarding measures for securing increased representation of Scheduled Castes and Scheduled Tribes in the Central Services, and to say that the following amendments may be made to the requisition form given as Annexure II to the aforesaid Office Memorendum of 7th May, 1955, with immediate effect:—

- 1. Item 6(a) should be read as under:—
 "Number of posts to be filled.
 - (i) Reserved for Scheduled Castes—Priority
 Reserved for Scheduled Castes—Non-priority
 - (ii) Reserved for Scheduled Tribes—Priority

 Reserved for Scheduled Tribes—Non-priority
 - (iii) Reserved for Ex-Servicemen
 - (iv) Unreserved—Priority
 Unreserved—Non-priority."
- 2. The form of certificate as given below item 9 may be substituted as under:—
 "Certified that the number of vacancies reserved for scheduled Castes/Scheduled Tribes and ExServicemen as mentioned in Col. 6(a) above is in accordance with the reservation quota fixed by
 Government for these categories."

Department of Personnel & A.R. O.M. No. 36022/4/76-Estt.(SCT) dated the 7th August, 1976 to all Ministries etc.

Subject:—Announcement of vacancies reserved for Scheduled Castes and Scheduled Tribes through the All India Radio—Recommendation No. 15 contained in the 41st Report of the Parliamentary Committee on Welfare of Scheduled Castes and Scheduled Tribes.

The undersigned is directed to say that the Parliamentary Committee on Welfare of Scheduled Castes and Scheduled Tribes has made the following recommendation in its 41st Report:—

Recommendation No. 15 (Para 2-11)

- "The Committee recommend that the Department of Personnel and Administrative Reforms in coordination with the Ministry of Information and Broadcasting, should devise a scheme by which vacancies reserved for Scheduled Castes and Scheduled Tribes are regularly announced or advertised from the various stations of All India radio and set timings for such programmes should be fixed so that Scheduled Castes and Scheduled Tribes candidates, living in remote areas where newspapers may not be easily available, become aware of such vacancies."
- 2. The above recommendation has been considered in consultation with the Ministry of Information and Broadcasting and it has been accepted for implementation. A State-wise list of All India Radio stations located in areas with concentration of Scheduled Castes and Scheduled Tribes population is enclosed. The Station Directors of these Stations have been instructed by the Ministry of Information and Broadcasting to broadcast announcements regarding the vacancies reserved of Scheduled Castes and Scheduled Tribes. Ministry of Finance etc. are now requested to advise their various attached/subordinate/offices/appointing authorities etc. to ensure that vacancies reserved for Scheduled Castes and Scheduled Tribes in Group C and Group D posts are notified to the appropriate Station Directors of All India Radio for announcement through that station. The following procedure may be followed in this regard:—
 - (i) At the time when the vacancies are notified to the local Employment Exchange to suggest names for the reserved vacancies, the appointing authorities concerned should simultaneously notify such reserved vacancies appropriately to one or more of the stations of the All India Radio, mentioned in the list referred to above.
 - (ii) If candidates belonging to Scheduled Castes and Scheduled Tribes are not available through the Local Employment Exchange, such vacancies are intimated to the Central Employment Exchange and they are advertised in the Newspapers either by the DGE&T through their periodical advertisements or by the appointing authorities themselves through the DAVP. Besides, notifying vacancies to A.I.R. stations according to the procedure in (1) above, the reserved vacancies should also be notified by the DGE&T/concerned appointing authorities to one more of the stations of the All India Radio mentioned in the aforesaid list, simultaneously with the advertisements in Newspapers.
 - (iii) The announcements of reserved vacancies on stations of the All India Radio should contain an advise to prospective candidates to get their names registered with the Employment Exchange of the area and to approach the Employment Exchange for further assistance.
- 3. Ministry of Finance etc. are requested to bring the above instructions to the notice of all concerned, for guidance and compliance.

Subject:—Reservations for Scheduled Castes and Scheduled Tribes—Intimation of reserved vacancies to Directors of Scheduled Caste/Tribe Welfare in the State/Union Territories.

The undersigned is directed to refer to the instructions contained in para 26 of the Brochure on Reservations for Scheduled Castes and Scheduled Tribes in services (4th edition, 1975) according to which in respect of vacancies filled by direct recruitment through the Employment Exchanges if sufficient number of SC/ST chadidates are not available through the Employment Exchange to fill the vacancies reserved for them, such vacancies are required to be advertised in newspapers and also brought to the notice of the Scheduled Caste and Scheduled Tribe organisations recognised for this purpose. Further according to the instructions issued in this Department's O.M. No. 36022/4/76-Estt.(SCT), dated 7-8-1976, in addition to the abovementioned steps, the reserved vacancies are also required to be notified to selected Stations of All India Radio located in areas with concentration of Scheduled Caste/Scheduled Tribe population. With a view further to giving wider publicity to reserved vacancies and exploring possibility of securing more candidates belonging to Scheduled Castes and Scheduled Tribes for vacancies reserved for them, it has now been decided that after the Employment Exchange has expressed its inability to sponsor Scheduled Caste/Tribe candidates against vacancies referred to it, the appointing authority should, in addition to the steps referred to above also intimate the reserved vacancies to the Director of Scheduled Castes/Scheduled Tribes Welfare or Director of Social Welfare in the State/Union Territory concerned. The Scheduled Caste/Tribe candidates who become available as a result of this step, should be considered along with other eligible candidates belonging to these communities for the reserved vacancies.

2. The Ministry of Finance etc. are requested to bring the above instructions to the notice of all the appointing authorities under them.

Subject:—Announcement of vacancies reserved for Scheduled Castes and Scheduled Tribes through the All India Radio.

The undersigned is directed to invite a reference to this Department's Office Memorandum No. 36022/4/76-Estt.(SCT), dated the 7th August, 1976 on the above subject and to say that with the coming up of Aurangabad as the main Station in the Aurangabad-Parbhani chain, the announcement of vacancies reserved for Scheduled Castes and Scheduled Tribes candidates are now being made from All India Radio, Aurangabad instead of Parbhani. In the State-wise list of All India Radio Stations sent with the above mentioned Office Memorandum dated the 7th August, 1976 necessary amendment may therefore be made in the list of All India Radio Stations substituting Auranganad for Parbhani. The Station Directors of these Stations have neen instructed by the Director General, All India Radio, Ministry of Information and Broadcasting to accept material for broadcast regarding vacancies reserved for Scheduled Castes and Scheduled Tribes of the All India Radio, Aurangabad instead of Parbhani in future. The Ministry of Finance etc., are now requested to advise their attached/subordinate offices that material for announcement regarding vacancies reserved for Scheduled Castes and Scheduled Tribes should be sent to All India Radio, Aurangabad instead of All India Radio, Parbhani.

2. The Ministry of Finance etc., are requested to bring the above to the notice of all concerned requesting them to substitute All India Radio, Aurangabad for Parbhani, in the list of All India Radio Stations.

Subject:—Notifying of vacancies reserved for Scheduled Castes/Scheduled Tribes to voluntary associations of SC/ST recognised for this purpose.

With reference to the above subject the undersigned is directed to say that it has been brought to the notice of the Government that vacancies reserved for SC/ST are not notified to the voluntary associations of SC/ST recognised for this purpose. It may be mentioned that to give wide publicity to reserved vacancies, so that more and more SC/ST persons can apply for the vacancies reserved for them, a number of voluntary associations have been recognised. Ministries/Departments are requested to notify the reserved vacancies to these associations.

OFFICE MEMORANDUM

Subject: - Notification of vacancies to Employment Exchanges.

In many departments direct recruitments to Group 'C' and 'D' are made from candidates who are sponsored by the District Employment Exchange or who have registered themselves in the Employment Exchange of the District in which the recruitment is made. For such recruitment the reservation percentage is proportionate to the population percentage of SC/ST in the respective States. It has been brought to the notice of this Department that certain Departments find it difficult to get sufficient number of ST candidates from the local District Employment Exchange, as the ST population in that District is negligible whereas there is a concentration of ST in certain other Districts of the State.

The matter has been examined in consultation with DGE&T, Ministry of Labour. DGE&T has clarified that as per the instructions contained in National Employment Service Manual, Volume I, candidates registered in other Employment Exchanges can be sponsored against the posts reserved for SC?ST, provided suitable local SC/ST candidates are not available with local Employment Exchange.

In view of the above, the recruiting authorities are enjoined to specifically mention in their requisition to the Employment Exchanges that if sufficient SC/ST candidates are not available with the local Employment Exchange, suitable SC/ST candidates from other Employment Exchanges may be sponsored. In the case of recruitment by advertisement where applications are called for from candidates registered in Local Employment Exchanges, if sufficient number of SC/ST candidates do not respond, then, in the second advertisement, SC/ST candidates registered in Employment Exchanges other than local one may also be made eligible to apply.

All the existing instructions regarding giving adequate publicity to reserved vacancies may be scrupulously followed.
