- Participating teams must reach the venue in time. In case any team fails to take the field within fifteen minutes of the scheduled time, walk over shall be awarded to their opponents.
- 9. Participating teams must maintain discipline on and off the field. Strict action shall be taken against the erring teams.
- 10. All the players must bring their Office Identity Card. The same may be produced whenever asked by the Convenor (Hockey). There is Prize Money of Rs. 10,000/- for Winner and Rs. 7,000/- for Runners-up Team.
