CIRCULAR

Sub : Inter-Ministry Lawn Tennis (Men and Women) Tournament 2023-24.

Central Civil Services Cultural and Sports Board (CCSCSB) is organizing Inter-Ministry Lawn Tennis (Men and Women) Tournament 2023-24 from 22nd to 31st July, 2023 at **CCSCSB Tennis Courts Brassey Avenue, New Delhi**. The Ministry/ Department desirous to participate in the tournament may send their entries in the prescribed proforma (Annexure-I) along with the entry fee. The entry fee for Team Championship is ₹600/-, for Singles and Doubles event is ₹100/- and ₹300/- respectively. Last date for submission of entries in the Central Civil Services Cultural & Sports Board office Room No 361, 'B' Wing, Lok Nayak Bhavan, Khan Market, New Delhi - 110003 is **18th July, 2023**.

2. There will be only one team from each Ministry. The Ministry may include in their team persons working in the attached and subordinate offices located at Delhi/ New Delhi. All teams/ Individuals would be represented as a part of Ministry's Team only. Central government autonomous organization like UPSC, Election Commission, C&AG's Office, Lok Sabha Secretariat, Rajya Sabha Secretariat, Cabinet Secretariat, PMO etc. can sent independent teams. The entries are to be sent through the Welfare Offices of the Ministry concerned.

3. The following categories of employees are not eligible for participation in this competition:-

(a) Uniformed personnel in Defence Services/Para Military Organisations/ Central Police Organisation/Police/RPF/CISF/BSF/ITBP/NSG etc.

(b) Employees of Autonomous bodies/Undertakings/Public Sector Banks/Corporations even though administratively controlled by the Central Ministries.

(c) Casual/Daily wages workers.

(d) Employees attached to offices on temporary duty.

In case, at any time, it is found that a player included in the team is not eligible, the team would stand automatically disqualified from the tournament.

4. No entry will be accepted unless accompanied with fee. The entry should be sent in the prescribed proforma (**Annexure I**) duly signed by the Welfare Officer concerned and should reach on or before the last date i.e. 18th July, 2023.

The entry fee should be deposited in the CCSCSB account after entering the following details:-

5. The competition will be held in the following events:-

- (i) Team Championship (Men)(06 Players + 01 Manager).
- (ii) Men's Singles
- (iii) Men's Doubles
- (iv) Men's Veteran Singles
- (v) Men's Veteran Doubles
- (vi) Women's Singles
- (vii) Women's Doubles
- (viii) Women's Veteran Singles
- (ix) Mixed Doubles

6. Winners and runners-up of team championship will also be awarded cash prize of ₹10,000/- and ₹7000/- respectively. If less than four (4) entries are received in any of the events mentioned in para 6 above, then, that event will not be held.

7. Referees'/Umpires' decision shall be final and binding on the competing teams.

8. Any information regarding change in dates/venue/cancellation etc. about the tournament will be available on our website i.e. www.dopt.gov.in . All participating teams are, therefore, requested to check the details of the tournament about any possible change.
