Sir,

I am directed to state that a representation received from Smt. Nutan Sinha, Guide (presently posted as Senior Technical Asstt. Archeology), Department of Art, Culture, Sports & Youth Affairs, Government of Bihar, for revision of her state allocation from the State of Bihar to the State of Jharkhand, on the ground of medical hardship (suffering from cancer), has been considered by the Central Government.
