Sir,

I am directed to refer to the above mentioned subject and to say that the Hon'ble High Court of Madhya Pradesh at Gwalior directed Union of India on 06.01.2010 in W.P. No. 5057/2008 to decide the representation of the petitioner by passing a fresh order in the matter of allocation taking into account the placement of the petitioner at Sl. No. 3667-A in the gradation list as on 31.10.2000.

2. On the basis of comments of Department of Water Resources the representation of Shri Parmal Singh Raghuvanshi was considered by the Central Government, consequent upon correction of his seniority rank from 4665 to 3667-A in the gradation list of Sub-Engineers as on 31.10.2000 and decided to revise his allocation from Chhattisgarh to Madhya Pradesh.



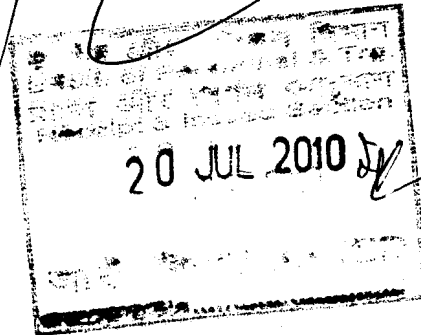

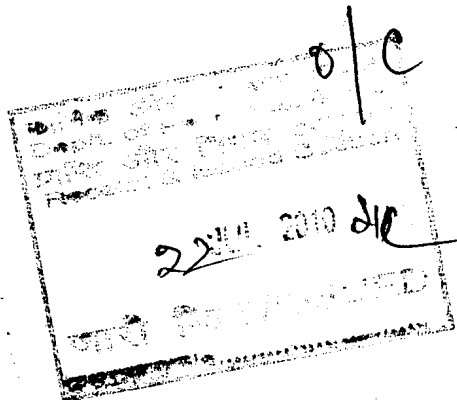
