The Central Civil Services Cultural and Sports Board is starting Football & Basketball Coaching for children/dependents (**both boys and girls**) of Central Government Employees on regular basis w.e.f 1nd October, 2014 at Vinay Marg Sports Complex, New Delhi.

2. The details of the Football & Basketball Coaching Scheme are as follows:-

- a) Age of Trainees: 8 years to 16 years.
- b) Days & Time: Wednesday & Saturday (Summer: 5 p.m to 7 p.m)
(Winter: 4 p.m to 6 p.m)
Sunday (Summer: 7 a.m. to 9 a.m.) (Winter: 8 a.m. to 10 a.m.)
- c) Fees: Football - Rs.500/- & Basketball- Rs.300/-
to be paid quarterly + one month's fee as security (refundable)
payment to be made before 5th of every quarter.
