CIRCULAR

Sub : Inter-Ministry Chess Tournament 2024-25.

Central Civil Services Cultural and Sports Board (CCSCSB) is organizing Inter-Ministry Chess Tournament 2024-25 from **09th to 18th December, 2024** at Grih Kalyan Kendra, Raja Bazar Community Centre, Gole Market, New Delhi. The Ministry/ Department desirous to participate in the tournament may send their entries in the prescribed proforma along with the entry fee. The entry fee for the events is **Rs.200/- for Individual and Rs.200/- for Rapid and Rs. 1,000/- for Team Championship**. Last date for submission of entries, Central Civil Services Cultural & Sports Board, Room No 361, 'B' Wing, 3rd Floor, Lok Nayak Bhawan, Khan Market, New Delhi – 110003 is **29th November, 2024**.

2. Women's Individual event will be conducted from **9th to 11th December, 2024** on "SWISS LEAGE SYSTEM" with suitable number (Max. 5) of rounds on the basis of number of entries received by the board. **The championship will be merged with individual Chess Championship in event of non-receipt of minimum entries for conducting the championship at the same venue and schedule.**

3. There will be only one team from each Ministry. The Ministry may include in their team persons working in the attached and subordinate offices located at Delhi/ New Delhi. All teams/ Individuals would be represented as a part of Ministry's Team only. Central government autonomous organization like UPSC, Election Commission, C&AG's Office, Lok Sabha Secretariat, Rajya Sabha Secretariat, Cabinet Secretariat, PMO etc. can send independent teams. The entries are to be sent through the Welfare Officer of the Ministry concerned.

4. The following categories of employees are not eligible for participation in this competition:-

- (a) Uniformed personnel in Defence Services/Para Military Organisations/ Central Police Organisation/Police/RPF/CISF/BSF/ITBP/NSG etc.
- (b) Employees of Autonomous bodies/Undertakings/Public Sector Banks/Corporations even though administratively controlled by the Central Ministries.
- (c) Casual/Daily wages workers.
- (d) Employees attached to offices on temporary duty.

In case, at any time, it is found that a player included in the team is not eligible, the team would stand automatically disqualified from the tournament.

5. No entry will be accepted unless accompanied with fee. The entry should be sent in the prescribed proforma (Annexure I) duly signed by the Welfare Officer concerned and should reach on or before the last date i.e. **29th November, 2024**.

6. The competition will be held in the following events as per schedule attached :
- Individual Men Championship.
 - Individual Women Championship
 - Rapid Championship
 - Team Championship (*4 Players, with one reserve players*).

7. All the participants should report to Shri Ram Ranjan Singh, Convenor, Chess at 10 am on 9th December, 2024. The detailed programme along with relevant details, rules and regulation will be supplied to the team/players at the venue of the Tournament. A tentative schedule of the tournament is enclosed at **Annexure-II**.

8. The rules and regulations governing the eligibility conditions for participation, etc. in the Inter-Ministry Tournament are available on the website of the Department of Personnel & Training (<https://dopt.gov.in/about-us/wings-or-division-in-dopt/welfare-divisions>).

9. Referees'/Umpires' decision shall be final and binding on all competing teams/players.
