Subject: Compliance of the directions of the High Court of Allahabad, Lucknow Bench dated 12.12.2007 in W.P. No.434(S/S)/2006- Decision on the representation of Shri Dileep Kr. Sharma Jr. Assistant, Naveen Prabhag – regarding

Sir,

I am directed to refer to the direction of the Hon'ble High Court of Allahabad, Lucknow Bench order dated 12.12.2007 and to say that the representation of Shri Dileep Kr. Sharma was considered by the Committee headed by Dr. S.K. Sarker, Joint Secretary in its meeting held on 24.8.2009. The Committee found that the representation has been submitted on the grounds that his promotion from class-IV to Jr. Assistant in 1999 is subject to the outcome of WP No.3602/98 filed by Class-IV employees Association & Others in High Court. The Committee was of the view that the case can be considered as per the guidelines if the petitioner is reverted to the post Class-IV employee as an outcome of WP No.3602/98. The Committee therefore, recommended to reject his representation and not to change his allocation from Uttarakhand to Uttar Pradesh subject to reconsideration if he is reverted to Class-IV as an outcome of WP No.3602/98.

The Government of India has accepted the recommendation of the Committee and accordingly Shri Dileep Kr. Sharma, Jr. Assitant, Naveen Prabhag remains allocated to Uttarakhand subject to reconsideration if he is reverted to Class-IV as an outcome of WP No.3602/98. Officer concerned may kindly be apprised of the position.

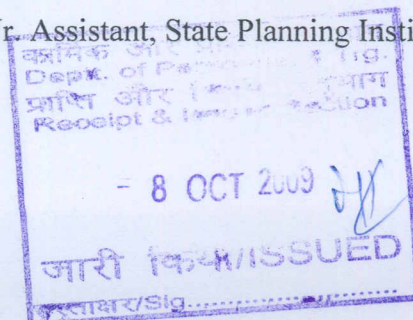
