The rest of the MOs who are not covered by any court orders, i.e. S/Sh. Dinesh Chandra Nautiyal, Dinesh Kumar Srivastava, Ravindra Pal Singh Negi, Durga Prasad Joshi, Buddhi Singh Bisht and Rajendra Prasad Singh are also certified to be included in the Hill Sub-Cadre by the Medical & Health Department. As per General Order No.27/9/2001-SRS dated 11.09.2001, all Hill cadre employees are deemed to be allocated to the State of

Uttarakhand and accordingly all the 28 Medical Officers brought out in para 1 and 2 above, stand allocated to Uttarakhand. Allocation orders for the rest, are being issued separately.
