The Women employees working in various Ministries/Departments located at Delhi/New Delhi may kindly send their entries in the prescribed Proforma (attached) along with the entry fee of Rs.75/- (Per Person) in the Central Civil Services Cultural & Sports Board Office latest by 11th October 2019, through the welfare officer of the Ministry Concerned.

2. Kindly note that event will be conducted on "SWISS LEAGUE SYSTEM" with suitable number (Max.5) of rounds on the basis of number of entries received by the Board. The championship will be merged with individual Chess Championship in event of non-receipt of minimum entries for conducting the Championship at the same venue and schedule. Medals will be awarded for first three positions.

3. No entry will be accepted unless accompanied with fee. The entry should be sent in the prescribed form duly signed by the Welfare Officer concerned and should reach on or before the last date mentioned above. The entry may be deposited in Board's account as per details.
