## Office Memorandum

Subject: Scale of personal staff of Ministers/Deputy Ministers and Parliamentary Secretaries - entitlement - revision thereof.

The undersigned is directed to refer to this Department O.M.No. 8/1/82-CS.II, dated the 30th January, 1982 and to say that the scale of Personal Staff of Ministers as intimated with this Department O.M.No. 20/1/62-CS(B), dated 27.6.1962, as amended from time to time, has been revised as per Schedule enclosed herewith. All the pending proposals may be decided in accordance with the scale given in the Schedule.

- 2. As per the aforesaid Schedule, all Ministers are now entitled to one Special Car Driver, co-terminus with the term of the Ministers. Where, however, in addition to the Special Car Driver, a Driver is provided to the Minister by the Ministry/Department concerned, no overtime allowance would be paid to either Driver.
- The scale of Personal Staff to Parliamentary Secretaries has also been revised as indicated in the enclosed Schedule. Accordingly, the existing post of Private Secretary sanctioned in the scale of Rs. 650-1200 will be redesignated as First P.A. and the post of P.S. will be created in the scale of Rs.1100-1600.

These orders will take immediate effect.
