As per the OM of even number dated 27th May, 2016, the distribution of blank ACR forms to the officers reported upon and submission of self-appraisal to the Reporting Officer by the officer to be reported upon was extended upto 15.8.2016.

- 2. It may be borne in mind that preparation and maintenance of filing APARs online is a priority reform area. Therefore, no relaxation will be granted by this department. The APARs received other than on-line mode except under the situations mentioned in the OM dated 27.5.2016 will not be accepted. Responsibility for its consequences will lie on the concerned administrative Ministries/Departments.
- 3. It is, therefore, once again request that progress made on the following activities under SPARROW may be intimated to this Department immediately:
 - 1. Nomination of Custodian, PAR Manager, EMD Manager.
 - 2. Generation of excel data in respect of Custodian etc., Officer to be reported upon, Reporting and Reviewing Officers and sending the same on line to NIC.
 - 3. Distribution of DSC to the concerned officers.

4. It is requested that the information may be provided to this Department by 1st September, 2016.
