  - b) The SLP (C) No.31288/2017 arising out of Hon'ble Delhi High Court Judgement dated 23.08.2017 in WP(C) No.3490/2010 filed by the All India Equality Forum & Others vs. UoI & Ors.
  - c) The SLP Nos.5724-5725/2019 in respect of S.N. Jasra & Raj Kumar against Delhi High Court's judgement dated 12.11.2018.
  - d) Any other connected court matter.
- ii) No disciplinary proceeding has been initiated during the period between last extension and now; and
- iii) No penalty has been imposed during the period between last extension and now.

3. In case any of these conditions is attracted in respect of any of the officers, the same may be brought to the notice of this Department immediately for further appropriate action.
