**Subject: Fixation of range of seniority for promotion from SSA(erstwhile UDC) of CSCS to Assistant Section Officer (erstwhile Assistant) of CSS-Select List for the year 2010(SQ)-reg.**

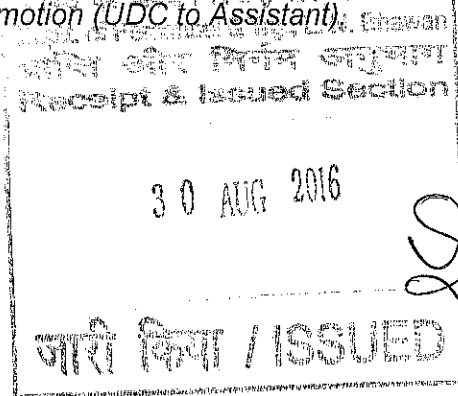
The undersigned is directed to refer to this Department's O.M. even number 3<sup>rd</sup> May, 2016 and subsequent reminders dated 16<sup>th</sup> May, 2016, 8<sup>th</sup> June, 2016, 18<sup>th</sup> July, 2016 and 1<sup>st</sup> August, 2016 on the subject mentioned above.

2. On perusal of the records it is observed that, only five cadre units have not furnished the complete information. The concerned cadre units are once again requested to furnish the DPC status/promotion order of the officials whose names appear in the Annexure of this O.M. It is re-iterated that DPC need to be held for the officers who were in service on crucial date i.e. 01-07-2010 but had retired subsequently on superannuation or otherwise (i.e. before their DPC could be held). However, their promotion order need not be issued by the cadre units.

3. Further Ministry of Social Justice & Empowerment is requested to cancel the office order no. A-12022/07/2009-Estt.I( Pt.) dated 13<sup>th</sup> June, 2016 as Shri Surinder Singh had retired from service before DPC could be held.
