**ORDER**

The order of ad-hoc promotion to the Grade of Under Secretary of Central Secretariat Service in respect of the 34 Under Secretaries was issued vide this Department's Order of even number dated 02.03.2021. Vide the said Order instructions were issued to concerned Ministries/Departments/Cadre Units to issue instructions to the promoted officers in the cadre units to assume the charge within 03 days of the Order, and officers who are on deputation and desirous to avail promotion were directed to submit their willingness within 03 working days and to join the promotion post within 07 days of issue of the order, failing which the promotion orders with respect to non-joiner officers will be liable to be withdrawn, apart from debarment from ad-hoc promotion or other suitable consequences.

2. These ad-hoc promotions were resorted to as a special dispensation for ensuring efficiency in Government's functioning and to address the urgent requirement of various cadre units for manpower at various level. Presently **03** Under Secretaries have still not joined/assumed the charge of the post of Under Secretary.

3. The non-joining/non-assumption of the charge to the promotional post tantamount to unwillingness to accept the offer of promotion. Accordingly, the order of ad-hoc promotion to the Grade of Under Secretary in respect of the following 03 Under Secretaries issued vide order of even number dated 03.02.2021 are hereby cancelled:



In addition, the following officer who was promoted to the grade of Under Secretary vide this Department's Order of even number dated 14.12.2021 has not complied with the instructions issued vide this Department's O.M. No.5/10/2020-CS.I(U)Pt dated 18.12.2020 & 19.12.2020 and as such his promotion order issued vide Order dated 14.12.2021 is hereby cancelled:
