

2. General Conditions:

- (i) **Period of engagement:** initially for a period of one year which is extendable further subject to satisfactory performance.



(vi) **Working hours:** Normal Office timings are from 9:30AM to 6:00PM. May also be required to attend office on holidays depending on exigencies of work.
