CIRCULAR

Subject: Engagement of retired Government Officers as Senior Consultant (1) on contract basis under Agriculture Census Division of the Department of Agriculture & Farmers Welfare, Government of India.

Applications are invited in prescribed format (as per Annexure) to engage eligible retired Government officials as Senior Consultant (1) on contract basis for the Project Monitoring Unit (PMU) under Agriculture Census 2021-22 project for a period of one year for undertaking various activities relating to monitoring of data collection, compilation/analysis/processing/preparation of report and dissemination of data of Agriculture Census 2021-22, in the Agriculture Census Division, Department of Agriculture and Farmers Welfare, Ministry of Agriculture & Farmers Welfare, Government of India, Krishi Bhawan, New Delhi.

2. The details of educational qualifications, experiences and other terms & conditions of the Senior Consultant are as under:

(i) Post: Senior Consultant.

(ii) **Educational Qualifications**: Post-Graduation in Statistics/Mathematics/Economics with knowledge of computer.

(iii) Experiences:

(a) Minimum ten (10) years' experience in designing and conducting large scale sample surveys, compilation/processing/dissemination and preparation of report at national level.

(b) Desirable: Retired from the post of Deputy Director or equivalent level and above from Central or State Government. Proficiency in MS office, knowledge of database, data analytics and report writing.

Note: *The qualifications and experiences are relaxable at discretion of the Selection Committee in case of candidates otherwise found suitable.*

(iv) Headquarter: New Delhi.

(v) Age-Limit: Age should not be beyond 65 years as on closing date of receipt of the application.

(vi) **Period of consultancy**: Initially for a period of one year. The contract could be extended further depending on requirement and assessment of performance and mutual willingness.

(vii) Remuneration & Emoluments: A fixed monthly amount shall be paid as per Government norms, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. There will be no annual increment/percentage increase during the contract period.

(viii) **Tax Deduction at source (TDS):** TDS as admissible shall be deducted from the monthly remuneration of Consultants. A TDS certificate shall be issued by the concerned DDO on demand.

(ix) Roles and Responsibilities: He/she would be the overall in-charge of the PMU for offering services relating to various activities of data collection, compilation, processing/dissemination of data of Agriculture Census 2021-22. These include:

- a) Overall in-charge of PMU under Agriculture Census 2021-22 project.
- b) Monitoring the progress of fieldwork of all three Phases for all States.
- c) Coordinate with all States/UTs for data collection, scrutiny, processing and finalization of data for all three Phases.
- d) Provide training or technical guidance to all States/UTs.
- e) Undertake field inspection for quality checking for all three phases.
- f) Examination/scrutiny of data for all States and prepare comments or submit report.
- g) Compare results with previous censuses data and other relevant sources for consistency.
- h) Prepare tabulation plan and other instruments for processing of data.
- i) Prepare training materials and All India Reports on Agriculture Census 2021-22.
- j) Other activities as assigned by the head of Agriculture Census Division.

(x) Method of Selection: The shortlisted candidates will be invited for personal talk/interview by a Committee constituted for this purpose, whose decision will be final and no correspondence in this regard will be entertained. Intimation shall be sent only to the selected candidate.

(xi) Terms and conditions:

- a) Retired Government Employees with relevant qualification and experience would be eligible for selection.
- b) The place of work will be Agriculture Census Division, Department of Agriculture & Farmers Welfare, Ministry of Agriculture & Farmers Welfare, Krishi Bhawan, New Delhi.
- c)' He /She will be paid total emoluments/entitlements (Consolidated) payable on expiry of each calendar month.
- d) He/She will not be entitled to any other allowance like HRA,CCA, accommodation facilities and other facilities such as regular transport/telephone connection etc.
- e) He/She will be eligible for TA/DA for undertaking official tour, if any, in connection with the implementation of the scheme as per TA/DA rules prevailing in Government of India. TA/DA for Senior Consultant will be paid as per their entitlement at the time of retirement.
- f) Excess payments, if any, made by the department (in the form of advance etc.) or any other agency will be recovered from him/her even after the expiry of the contract.
- g) Position is purely temporary, initially for a period of one year, extendable from time to time depending on requirement and performance of the incumbent.
- h) The incumbent shall have no right or claim whatsoever for absorption/regularization on the strength of the Ministry.
- i) There is no provision for re-employment after termination of the assignment.
- j) Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year may not be allowed.

- k) The engaged persons shall not indulge or disclose to any person, any details of office, operational process, technical know-how, security arrangements, and administrative/organizational matters as all are of confidential/secret nature.
- The engagement can be discontinued by the competent authority, without assigning any reason. However, the engaged persons will have to give one month advance notice or remuneration in lieu thereof before resigning from the engagement.
