 - (c) The Writ Petitions filed before the Hon'ble Delhi High Court challenging the common order dated 21.03.2018 of Learned CAT, PB, New Delhi in OA No. 1111/2017 and OA No.1596/2017; and
 - (d) Writ Petitions No. 6597/2012 and 3003/2013 before the Hon'ble High Court of Delhi;
 - (e) O.A No. 3020/2018 before the Hon'ble CAT (PB), New Delhi.
 - (f) Any other court case in a connected matter.
- 6. Copy of notifications should invariably be enclosed to this Department for record. If any of the officers included in Director Select List 2017 cannot be appointed to the grade of Director on regular basis, the same may be brought to the notice of this Department immediately along with reasons.
