ORDER

Approval of the President is hereby conveyed for inclusion of officers as per Annexure to this order, in the Senior Selection Grade Select List (SSGSL) of Central Secretariat Services for the year 2022 (Director Grade) **for the vacancies arising till 01.08.2022.**

2. The appointment of officers will be effective from the date of assumption of charge of the post.

3. All the officers as indicated in the Annexure are retained in the respective Ministries/Departments where they are currently posted on their regular promotion to the Grade, until further orders.

4. The seniority of the officers included in the aforesaid Select List, will be in the same order in which their names have been recommended for inclusion, irrespective of actual dates of their appointment to the Senior Selection Grade.

5. In terms of Rule 2(c) (iii) of CSS Rules, approved service in the grade of Director will count from 1st July of the Select List Year.

6. In terms of CSS Regulations, 2010, an eligible officer for inclusion in SSGSL should have successfully undergone such mandatory training programme as may be prescribed under Cadre Training Plan of DoPT. In terms of CSS (CTP), successful completion of Level F Training is mandatory for inclusion in SSGSL.

6.1 However, the Competent Authority under Rule 23 of CSS Rules, 2009, in consultation with UPSC, has approved grant of one time relaxation in the provision of successful completion of mandatory Level-F training for appointment as Directors on inclusion in Select List from Select List Year 2018 onwards up to the Select List year 2022. However, these officers, except those falling under the exempted category, are required to complete the Level-F training as per the nomination made by this Department.

7. The concerned Ministries/ Departments are requested to notify the appointment of these officers to the grade of Director on regular basis from the date of assumption of the charge of the post of Director.


8. The Ministries/ Departments, before issuing the notification, shall ensure that the officer(s) concerned is/are clear from vigilance angle in terms of DoPT O.M. No. 22034/4/2012-Estt (D) dated 2.11.2012 read with O.M. No. 22011/4/91-Estt(A) dated 14.9.1992 and O.M. No. 22012/1/99-Estt(D) dated 25.10.2004. In case of any change in the vigilance status of the officer from the last report, the same may be communicated to AVD.I and CS.I Division of this Department immediately.

8.1 In case of currency of any penalty imposed on an officer included in the Select List, notification should be issued only after the currency of the penalty is over in terms of DoPT's O.M. No.22034/5/2004-Estt(D) dated 15.12.2004. Such cases should be informed to this Department separately.

9. The inclusion of these officers in SSGSL 2022 will remain subject to further orders of the Hon'ble Supreme Court of India in the Civil Appeal No. 629 of 2022 arising out of SLP(C) No. 30621/2011 titled Shri Jarnail Singh & Ors. V. Lachhmi Narain Gupta & Ors. and other connected matters.

10. The copies of notifications for regular appointment of officers should invariably be endorsed to this Department for record. In case any of the officers included in the Select List cannot be appointed to the Grade of Director on regular basis, the same may be brought to the notice of this Department immediately along with the reasons.
