5. **All the candidates residing in Delhi** are advised to appear before the Civil Surgeon/ Chief Medical Officer, Dr. RML Hospital for the medical examination to determine their fitness for the Government service. The candidates should report at 8.00 AM in Room No. 235, OPD Block, Dr. Ram Manohar Lohia Hospital, New Delhi on any working day before 14th June, 2019 for the appointment date and time of medical examination.

6. **All the candidates residing outside Delhi** are advised to appear before the Civil Surgeon/ Principal Medical Officer / Chief Medical Officer of the District where the candidates are presently residing, for the medical examination to determine their fitness for the Government service.

7. All the candidates are required to give a statement and declaration regarding his/her health in the attached form in the presence of Medical Officer. The medical examination report and declaration in original shall be furnished to this Ministry as soon as possible. The medical certificate of fitness should be in the prescribed format, a specimen of which is attached. In case any other letter is required by the office of CMO concerned, the undersigned may be contacted. However, if the candidate is already in government service, instead of obtaining a fresh medical report, they may produce this letter to their controlling authority to enable them to forward an attested copy of their character and antecedents report, vigilance clearance and medical examination report obtained at the time of appointment in the present service, to the undersigned.


8. The candidates who submit the requisite documents (willingness, attestation form, medical fitness report etc) shall be considered for nomination to the mandatory Stenographers Direct Recruit (SDR) Foundational Training Programme organized by Institute of Secretariat Training and Management (ISTM), Delhi, which is likely to be scheduled in the month of August, 2019.

9. Mere submission of willingness and forms will not entitle any claim to appointment to the post which will be subject to fulfillment of stipulated terms and conditions.
