seven (7) years in the pre-revised pay scale PB-4 with Grade Pay Rs. 8,700/- or equivalent IDA scale in Central/ State Government/ UT Administration/ Universities/ recognised Research Institution / PSUs/ Semi Govt./ autonomous organisation.

#### 4. Age limit:

Applicant must not exceed 58 years of age on the closing date of receipt of application i.e. 18.12.2022.

Incumbent shall hold office for such period not exceeding 05 years and not beyond 60 years of age whichever is earlier and will further subject to Terms and conditions issued by DoPT in r/o Deputation.

**Note:** The reference date for determining the age for eligibility shall be the closing date for receipt of application.

#### 5. Screening and selection process:

The screening and selection process shall be as decided by Selection Committee so constituted by the NCDWSQ and mentioned in RRs. If considered necessary, the screening process may include interview.

#### 6. Duties

The Director & Head of the Centre is responsible for overall administration of the affairs and the funds of the Centre. As the Head of the Centre he is to undertake activities to further its role as the apex institution in the country in drinking water quality & sanitation sector. This includes working with the State Public Health Engineering Departments/ Water & Sanitation Departments, establishing collaboration with other reputed institutions, conducting training and academic programmes and undertaking research and innovation.

#### General

- i.) The Department reserves the right to cancel the recruitment without assigning any reason.
- ii.) The vacancy for the post of Director is un-reserved.
