The National Commission for Safai Karamcharis, New Delhi invites application to fill up the post of Deputy Director (Research & Development) on deputation basis. The period of deputation will initially be for three years or till further orders, whichever is earlier. The eligibility criteria and qualifications for this post are as follows:

2. Period and other terms and conditions of deputation:

The initial period of deputation will be for three years, extendable (one year at a time, total 3 years) by a further period as per guidelines of Department of Personal & Training's O.M.No. 6/8/2009. Estt.(Pay-II) dated 17.06.2010. The terms and conditions of deputation will be governed by the above mentioned DoP&T's O.M. dated 17.06.2010 and Government of India's Instructions issued from time to time on the subject. The deputation allowance as applicable will be allowed as per existing rules.

Age Limit: The maximum age limit for appointment on deputation shall not exceed 56 years as on the closing date of receipt of application,

3. Eligible and willing officers, working in Ministries/Departments of Central Government, may apply through proper channel in prescribed format- ANNEXURE-I. Cadre Controlling Authorities/Head of Departments are requested to forward applications of eligible and willing officers whose services can be spared on deputation immediately on their selection. 
