If the outstation post is vacant or the present incumbent has completed the prescribed tenure, the action taken to fill up the post/to find a replacement as per para 15(i) of RTP dated 16.07.2015 may also be intimated. In this connection it is clarified that an SO/ASO is allowed a tenure of seven years in current posting of an outstation office irrespective of the tenure rendered in the main Ministry/Department at Delhi or previous tenures in the outstation office/ location. The combined current tenure rendered in the current designation and in lower designations in the same outstation office will be counted for tenure.
