2. The categories of Benchmark Disability identified as suitable for the post of Under Secretary of CSS in terms of Department of Empowerment of Persons with Disabilities Notification dated 04.01.2021 are as under:

1	a	Blindness & Low vision	B, LV
2	b	Deaf and hard of hearing	D, HH
3	c	Locomotor disability including leprosy cured, dwarfism, acid attack victims,	Locomotor Disability – OA, OL, OAL, BL, Leprosy cured (LC), Dwarfism (Dw), Acid Attack victims(AAV)
4	e	Multiple disabilities from amongst clauses a, b & c above, but including the deaf and blindness.	OA, LV; OL, LV; OA, HH; OL, HH; LV, HH
