OFFICE MEMORANDUM

Subject: Supplementary zone of consideration for inclusion in **Select List of Section Officers' Grade of CSS for the year 2012 against Seniority Quota** - regarding

The undersigned is directed to refer to this Department's OM of even number dated 21.05.2022, vide which the supplementary zone of consideration for inclusion in the Select List for the year 2012 of Section Officers' Grade of CSS under Seniority Quota was issued.

2. The Cadre Units concerned were requested to conduct DPCs and forward the DPC recommendations along with a copy of the minutes of DPC and vigilance clearance of the officer concerned to this Department compulsorily by 27.05.2022. However, DPC recommendations in respect of the following 5 officers are still awaited:

3. Finalization of SO CSL 2012 and issue of supplementary zones, if any, against SO SLs under Seniority Quota for 2013 and onwards are getting delayed inordinately due to non-receipt of DPC recommendations in respect of the above officers. The cadre units concerned are, therefore, requested to furnish the DPC recommendations in respect of these 5 officers **immediately but not later than 18.10.2022** clearly grading them as 'fit/unfit or in sealed cover (in case the officer is not clear from vigilance angle)'. Failing which, the matter shall be reported to the Secretary of the concerned Cadre Units for necessary action.
