Subject: Combined Section Officers'/Stenographers' (Gr.'B'/Gr.I) Limited
Departmental Competitive Examination (LDCE), 2015 – regarding


The undersigned is directed to refer to this Department's OM of even number dated 27.04.2021 vide which 440 CSS/CSSS officers were included in the Section Officers Select List for the year 2015 against Examination Quota on the basis of results of SOs/Stenos (Gr.I/Gr.B) Limited Departmental Competitive Examination (LDCE) 2015 declared by UPSC on 15.04.2021.

2. The promoted officers were directed to assume charge of the post of Section Officer, on regular basis **on or before 05.05.2021**. The cadre units concerned were requested to issue orders, appointing these officers as Section Officers **latest by 07.05.2021**, subject to assumption of the charge the promoted post. It was also stipulated that If any officer presently serving in the cadre, fails to assume charge of the post of Section Officer, **on or before 05.05.2021**, without the prior approval of the Cadre Controlling Authority (DOPT) for extension of joining time, his/her inclusion in the select list for 2015 may be liable to be cancelled.

3. As per the joining reports/promotion orders/Notifications received from Cadre Units, the following candidates have neither assumed charge of the post of Section Officer on regular basis against SO SL 2015 by the stipulated date nor submitted their unwillingness in writing:
