OFFICE MEMORANDUM

Subject: Extension of period of ad-hoc appointment in the grade of Section Officers of CSS – regarding.

The undersigned is directed to refer to this Department's OM of even number dated 29.06.2021 vide which the period of ad-hoc promotion in SO grade was extended upto 30.06.2022.

2. Even after the recent regular promotion exercise in various grades of CSS including SO grade, as per the information available in this Department the service of 20 ad-hoc Section Officers (as per list enclosed) could not be regularized as on 01.07.2022 due to various reasons such as vigilance/disciplinary/court proceedings were pending against them, had not completed the Level B mandatory training or were on long leave/training etc. Some of them were promoted on regular basis on a date after 01.07.2022.


3. For consideration of extension of period of ad-hoc promotion of these officers beyond 30.06.2022, it is to be ensured that the officers are clear from vigilance angle in terms of this Department's No.11012/9/86-Estt.(A) dated 24.12.1986. However, in respect of officers who have completed more than 1 year as ad-hoc SOs, no fresh vigilance clearance is required. In respect of officers, who have not completed the mandatory Level B training, the reasons for not attended/completing the training may also be furnished to consider continuation of his/her adhoc appointment as SO.

4. In view of the above, Cadre Units are requested to:

- i. Scrutinize the attached list of ad-hoc Section Officers and intimate discrepancies there in, **especially additions/deletions, if any**
- ii. Forward vigilance clearance certificate of the officers who had not completed more than 1 year as ad-hoc SOs as on 01.07.2022
- iii. Submit the updated status of the vigilance/disciplinary/court proceedings, if any, pending against any of these officers.
- iv. If the officer is on leave/training, intimate the status of DPC recommendation in respect of the officer and the likely date of his/her return from leave/training.
- v. If any of these officers has already been promoted as Section Officer on regular basis, intimate his/her date of regular promotion and the SO SL Year.
