ORDER

This Department issued the zone of consideration for promotion of ASOs of Select Lists 2010 as Section Officers on ad-hoc basis vide OM of even number dated 14.06.2019. The Cadre Units were requested to conduct Screening Committee meetings and promote the officers, who have been found fit, to the extent of available regular vacancies. They were further requested vide para 8 of the above mentioned OM, to relieve the ASOs, who have been found fit, but could not be promoted due to shortage of vacancies in SO grade, for reporting in CS-I Division for posting to other cadre units where vacancies in the SO grade exist.

2. In accordance with the above instructions, 20 ASOs, who were surplus in their respective Cadre Units, have reported to CS-I Division for availing promotion as Section Officer on ad-hoc basis. The effective date of promotion as Section Officers on ad-hoc basis in respect of these 20 officers shall be **01.07.2019(FN)**.


