### OFFICE MEMORANDUM

Subject:-Fixation of range of seniority for promotion from SSA Grade of CSCS Cadre to ASO Grade of CSS cadre for the Select List Year, 2013 (part) under Seniority Quota-reg.

The undersigned is directed to say that there are two lists of SSAs for Select List Year 2003. The first one is SL-2003(original) consisted of 81 SSAs which was prepared in the year 2005. The second one is SL-2003(Extended) which was prepared in the year 2012 onwards in a phased manner for filling up of 2151 percolated vacancies of SSAs which arose on account of implementation of 1st Cadre Review in CSS for the year 2003. The Select List and Common Seniority List of 2003(Extended) was finalized on 06.10.2015 and 02.11.2015, respectively. As the O.M. dated 06.10.2015 and 02.11.2015 are under litigation before the Hon'ble High Court of Delhi in WP No. 8454/2019 and 8616/2019, the regular promotion of the SSAs included in that lists cannot be made as of now. As there is no seniority dispute of the SSAs of SL-2003(original), with the approval of competent authority it has been decided to grant them regular promotion against **Select List Year, 2013 of ASO Grade (part).** 

2. For preparation of this part SL of ASO for 2013, the zone of consideration is hereby issued for assessing their suitability for promotion to ASO grade against the following backlog vacancies of SL-2012 which has been carried forward to SL Year 2013 of ASO Grade:-

- 3. The range of seniority who are eligible for assessment by DPC for their suitability for promotions shall be:-
  - (i) All the eligible SSAs of SL 2003 (original) consisting of 81 officials (Annexure-I) SSAs who were in service and completed 10 years of approved service as on 01.07.2013 and also qualified mandatory Level-A training programme conducted by ISTM; and
  - (ii) SSAs of earlier Select Lists who were in service and completed 10 years of approved service as on 01.07.2013 and also qualified mandatory Level-A training programme conducted by ISTM,

- 4. The cadre units are requested to conduct DPC in respect of the SSAs of SL-2003(original) and earlier SSAs, if any, for assessing their suitability for inclusion to the grade of ASO under Seniority Quota on regular basis for the part Select List Year, 2013 and based on the recommendations of the DPC issue promotion orders in respect of the officers found suitable for promotion in all respects with the approval of competent authority. However, the orders for regular promotion should be issued subject to the following conditions:-
  - (i) The official concerned is clear from vigilance angle in terms of this Department's OM No. 22034/4/2012-Estt.(D) dated 02.11.2012 and other relevant instructions on the subject;
  - (ii) If an officer is undergoing penalty, notification should not be issued for regular promotion and in such cases notification should be issued only after the currency of the penalty is over in terms of DoP&T's O.M. No. 22034/5/2004-Estt.(D) dated 15.12.2004, Such cases should also be informed to this Department.
  - (iii) The officers, who were in service on the crucial date of the Select List Year i.e. as on 01.07.2013. In case any SSA had already retired as SSA subsequently on account of superannuation/demise or otherwise, should be considered for inclusion of their names in the aforesaid part Select List of ASO in pursuance of this Department's OM No. 22011/4/98-Estt.(D) dated 12.10.1998 to identify the correct zone of consideration for the relevant Select List. However, their appointment should not be notified as the retired persons would not be available for actual promotion from a prospective date.
  - (iv) Some officials included in the zone of promotion for the Select List of ASO for the year 2013 under seniority quota may be on deputation as on date. To avail the benefit of promotion, such officers have the following two options; either they may repatriate to their parent cadre; or they may avail proforma promotion from the date of promotion of their immediate junior. All Ministries /Departments are, therefore, requested to consider the requests for proforma from the date of promotion of their junior. All Ministries/Departments are, therefore, requested to consider the requests for proforma promotion, if any, in terms of extant instructions and issue necessary orders without referring the matter to this Department.
  - (v) Outcome of the Jarnail Singh batch of cases as per para 5 of the O.M. No. 36012/16//2019-Estt.(Res.) dated 12.04.2022.
- 5. Eligible officials may be regularized "as is where is basis" i.e. in the cadre units where they are presently working within the sanctioned strength in that cadre unit. Cases of refusal of promotion may be dealt with as per instructions contained in Department's O.M. No. 22011/5/86-Estt.(D) dated 10.04.1989. The relevant extract of the said O.M. was circulated vide this Department's OM No. 5/1/2008-CS.I(S) dated 08.04.2011.

- 6. A consolidated report indicating the name and details of the officials who have been regularized in ASO Grade against the Select List Year 2013 and a list of those SSAs who have not been regularized, with reasons, may also be furnished to this Department in the prescribed proforma (**Annexure-II**) latest by 31<sup>st</sup> May, 2022.
- 7. If any officer included in the list is working in any cadre unit other than the one indicated against his/her name in **Annexure-I**, the cadre unit, where he/she is presently posted, may conduct the DPC in respect of him/her and may also be brought to the notice of this Department for corrections.
