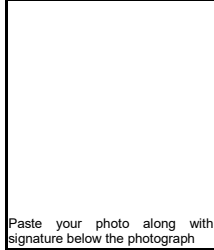

TERMS OF REFERENCE

Terms & Conditions for appointment of Consultants in Commission of Railway safety, Ministry of Civil Aviation on Contractual basis.

1. Eligibility Criteria:

- The Consultants proposed for engagement shall be well acquainted with the functioning of Central Government Ministries/Departments.
- Applicants should have retired from the post equivalent to the post of Section Officer/Assistant Section Officer (i.e. officials retired from Level-7 to Level-10 as per 7th CPC) from Central Govt. Ministries/ Departments including its Attached/Subordinate offices.
- Applicants should have adequate experience in Administrative matters like Appointments (Regular/Ad-hoc/UPSC/ACC), Service Matters, Parliament Committee Matters etc. and Financial matters like Budget preparation & related work, PFMS, AUDIT matters etc.
- He/She shall have experience in framing Rules/Regulations in establishment matters and in financial matters.
- He/She is expected to possess adequate competency in preparation of reports/documents/correspondence, by their own.
- He/She shall possess adequate working knowledge of computers & software tools like MS-Word, Excel & Power Point.
- Applicants with experience in administrative ministries like (UPSC/DoPT) or financial ministry (like M/o Finance) or Commission of Railway Safety would be preferred.

2. Age Limit:

The upper age-limit of candidates shall not be more than 5 years of their superannuation age as on closing date of receipt of application.

3. Leave:

Consultants shall not be eligible to leave for more than 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year may not be allowed.

4. TA/DA

No TA/DA shall be admissible for joining the assignment or on its completion. Consultants will not be allowed foreign travel at Government expenses. However, Consultants shall be allowed TA/DA for their travel inside the country in connection with the official work as per government rule.

5. Type of appointment:

The appointment will be purely on contract basis.

6. Contract Period:

Initial contract would be for a period of one year extendable for further period as may be decided by the Ministry.

7. Terms of Payment of remuneration:

The maximum remuneration to be paid to retired government servants/consultants shall be last pay drawn minus pension plus Transport Allowance (TA) as per para 7.2 of the Department of Expenditure O.M.No.3-25/2020-E.IIIA dated 09/12/2020.

8. The Department reserves the rights, as follows:

To decide to cancel this advertisement, and not to proceed in the matter, at any stage accept or reject any or all applications, without giving any explanation, whatsoever.

9. Basis for Evaluation:
