Scope of Work	<ul style="list-style-type: none">• The roles of Consultant will include suggesting inputs and strategies for areas of collaboration with different other Ministries, Depts. and Agencies and explore possibility of developing Projects and Programmes for Youth Development and Empowerment. This synergy will enable more resource for youth development activities and bring in multiplier effect on the outcome.• The Consultant shall lend support and provide requisite expertise to plan, guide and broaden the scope and outreach of Focus Areas identified by RYSK in its Annual Action Plan and Scheme of Dept. of Youth Affairs as well as provide guidance for their wider outreach, visibility and impact.• Coordination in Parliamentary matters shall require an experienced official well acquainted with the Parliamentary Procedure.• Coordination with various organization under the Ministry such as NYKS, NSS, RGNIYD etc.• Work experience in the government setup and high level of communication is one the most important criteria which is to be fulfilled by the consultant.• Compilation of data relating to activities/programs of RYSK, PPT presentation before various Parliamentary Committee.

8.	Remuneration	<ul style="list-style-type: none"> A fixed monthly amount will be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. There will be no annual increment/percentage increase during the contract period. <p><u>Example</u></p> <p>An employee retired in the Pay Level 13 and the pay at the time of retirement was Rs. 1,55,900. Thus, the basic pension will be 77,950. If the employee is appointed on contract basis, including as Consultant, the remuneration shall be fixed at Rs. 77,950 (1,55,900-77,950).</p> <ul style="list-style-type: none"> An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment. However, retired employees engaged as consultants may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
9.	Leave	1.5 paid leave for every completed month.
10.	Working Hours	<ul style="list-style-type: none"> Normal office timing from 09:00 a.m. to 05:30 p.m. May also have to devote more time than usual to meet the exigencies of work, if required.
11.	Terms of Engagement	The engagement will be on hire & fire basis which is purely dependent on their work performance.
