- 2. It is requested that a panel of suitable CSS officers may be sent to this Department along with their ACR dossiers for considering them for the said post. These officers will be considered alongwith the eligible officers in MPEDA and those working in the Department of Commerce.
- 3. The panel may be sent by <u>21<sup>st</sup> April</u>, <u>2008</u> so that a suitable officer can be selected for this post before the tenure of existing incumbent expires on 6<sup>th</sup> June, 2008.
