



ORDER

In pursuance of Rule 20 of the Central Secretariat Service (CSS) Rules, 2009 and Rule 20 of the Central Secretariat Stenographers' Service (CSSS) Rules 2010, the Central government in Ministry of Personnel, Public Grievances and Pensions (Department of Personnel and Training) hereby constitutes with immediate effect, new cadre unit for Ministry of Panchayati Raj in respect of various grades of CSS and CSSS, by carving out the same from the existing cadre unit of Ministry Rural Development.

2. The sanctioned strength of various grades of CSS and CSSS in the separated cadre-unit of Ministry of Panchayati Raj is given in Annexure. No new posts will be created in Ministry of Panchayati Raj for setting up a system for cadre management/administration of CSS/CSSS personnel.
3. The present incumbents in the various grades of CSS and CSSS shall remain posted in the respective Ministries on as is where is basis to the extent of sanctioned strength as per Annexure to this order and excess officers in any grade should be reported to CS.I/CS.II Division for further necessary action.
4. However, CSCS personnel of Ministry of Panchayati Raj will continue to be a part of CSCS cadre of Ministry of Rural Development.
