The undersigned is directed to refer to the appointment letter(s) issued to the ASOs of CGLE 2016 vide letter No. 7/10/2017-CS-I (A) dated 11.04.2018 and subsequent dates *inter-alia* containing the following condition:

“the appointment to the post of Assistant Section Officer (ASO) in Central Secretariat Service (CSS) on the basis of CGLE 2016 shall be subject to the final outcome of the Writ petition to be filed by the Commission before the Hon’ble High Court of Delhi against the Order dated 23.10.2017 passed by the Ld. CAT, Principal Bench, New Delhi in OA No. 2964/2017 filed by Shri Rohit Kumar and Ors./any other litigation (OAs/WPs/SLPs), as the case may be”

2. Staff Selection Commission has now informed that Hon’ble Supreme Court vide its order dated 22.11.2019 had dismissed the plea of UOI in the SLP(C) 18743/2018 (UOI Vs Sumit Kumar) and consequent to this, Hon’ble HC of Delhi in WP 3457/2018 filed by UOI against the Order of the Hon’ble CAT dated 23.10.2017 in OA 2964/2017, disposed off the said WP vide order dated 06.02.2020 with the direction to comply the Order dated 23.10.2017 of Hon’ble CAT (PB), New Delhi.

3 Accordingly, the above condition mentioned in the appointment letters of the ASOs of CGLE 2016 stands withdrawn and the appointment of all the ASOs of CGLE 2016 is, hereby, declared **UNCONDITIONAL**.

“the appointment to the post of Assistant Section Officer (ASO) in Central Secretariat Service (CSS) on the basis of CGLE 2017 shall be subject to the final outcome of the WP No. 234/2018 filed by Shri Shantanu Kumar & Ors before the Hon’ble Supreme Court of India, as the case may be”

2. Staff Selection Commission has now informed that the Hon’ble SC disposed of the above mentioned WP vide its order dated 05.03.2020. As such the final results of CGLE 2017 declared on 15.11.2019 are now free from that condition.
