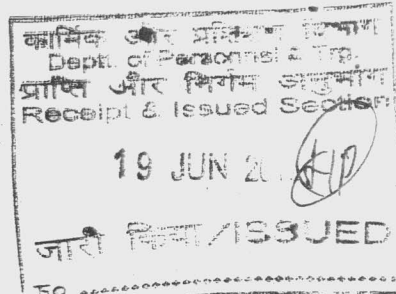
OFFICE MEMORANDUM
