OFFICE MEMORANDUM

Subject: Scale of Personal Staff of Union Council of Ministers – Entitlement of Minister of State & Deputy Ministers holding additional charge of another Ministry or Department under another Ministry – regarding.

The undersigned is directed to say that the scale of personal staff for Ministers etc. laid down in this Department's O.M. No.8/5/85-CS.II dated 4.4.85 as amended from time to time, inter-alia provides that a Minister of State holding additional charge of another Ministry or a Department under another Ministry will be allowed one additional post of Special Private Secretary, if the same is required by the Minister. The instructions regarding provision of one additional post of Special Private Secretary to Minister of State were, however, kept in abeyance by this Department's O.M. No.8/5/85-CS.II dated 8.12.1992. Further, this Department's O.M No.8/17/88-CS-II dated 7.6.89 provides that when a Deputy Minister is given additional charge of another Ministry/Department and is required to function from two different locations, he is entitled to have one Personal Assistant and one Peon (in addition to the normal entitlement).

2. The matter regarding provision of additional personal staff to the Ministers of State and the Deputy Ministers, having <u>additional charge</u> of another Ministry or a Department under another Ministry has been reviewed further and it has now been decided to provide a separate set of personal staff for the additional charge, to the extent indicated below: -
