

Essential Qualification: (including Short term contract)

- (a) (i) holding analogous posts on a regular basis in the parent cadre or deputation;
Or
(ii) with five years' service in the grade rendered after appointment thereto on a regular basis in posts in the Pay Band-3 [₹ 15,600-39,100/-] with Grade Pay of ₹ 7,600/- or equivalent in the parent cadre or department; and

- (b) Possessing the following educational qualifications and experience:

- (i) Doctorate degree in Food Science and Nutrition or Applied Nutrition or Food and Nutrition or Bio-Chemistry or Food Technology and Chemical Science or Home Science or Food Science and Technology from a recognized University or Institute; and
(ii) Ten years' experience in implementing community nutrition programmes or programme planning in nutrition and health or research in the field of nutrition supported with publications having impact factor.

Note 1: The departmental Joint Technical Adviser in the Pay Band-3, 15,600-39,100/- with Grade Pay of 7,600/- with five years regular service in the grade shall also be considered along with the outside candidates and in the case such person is selected for appointment, the post shall be deemed to have been filled by promotion.

Note 2: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

- Note 3: The period of deputation (including short-term contract) including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the central Government, shall ordinarily not exceed five years.
- Note 4: The maximum age limit for appointment by deputation including short-term contract) shall not be exceeding 56 years as on the closing date of receipt of applications.
- Note 5: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006 or the date from which the revised pay structure based on the recommendations of the Sixth Central Pay Commission has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the said Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.
