- Coordinates with new project group for minimization of R&R issues at the project exploration stage to avoid social issues.
- R&R plan finalization, approval, modification its implementation and closure of R&R
- Takeover of physical possession of Land & transfer of ownership to NTPC Ltd.
- Formulation and approval of Initial Community Development (ICD) plan.
- Any other assignment given from time to time.

Job Profile
