Subject: Filling up the post of Internal Financial Adviser, Department of Atomic Energy, Mumbai - regarding.

It is proposed to fill up a vacancy of Internal Financial Adviser, Department of Atomic Energy, Mumbai.

2. Officers of the rank of Dy. Secretary/Director level from any Organized Finance & Accounts Service of the Government of India or equivalent level, eligible for appointment under the Central Staffing Scheme are eligible for the post. The period of deputation is 4/5 years for Dy. Secretary/Director respectively.
3. The post may be circulated amongst officers eligible to be appointed at Dy. Secretary/Director or equivalent level in the Government of India on priority basis.
